



# EUROPEAN BOXING UNION asbl (EBU) AGREEMENT OF EBU-CHAMPIONSHIP CONTEST

## EBU, SILVER, FEMALE -CONTEST

(All blank spaces must be filled-in, deletions are not valid nor permitted)

1. All sums of money indicated in this contract are in .....(to indicate currency).

7. The gloves shall be selected from the list of EBU-recognized ones and shall be provided by the  
 Promoter at his expense; four pairs of equal gloves must be submitted to the Supervisor at the weigh-  
 in.

The parties may agree in writing to use different gloves from the list, but have to inform the Promoter  
 at the latest 14 days before the contest.

In case of disagreement the local Federation will decide.

8. The net purse for the boxer's contest which includes all ancillary rights in the currency agreed before  
 is as follows:

The total sum (purse and expenses) to be received by the Boxer after the contest shall be free of all  
 taxes.

9. No champion nor challenger shall box less than 28 days before he/she is due to box for an EBU-title.  
 In the event of an alteration in any sporting worth of the contest (anything affecting the contest)  
 between the date of signing this contract and the date of its execution (e.g. case of defeat) the  
 Promoter may claim a reduction of the amount of the purse agreed in item 8, but not more than  
 ..... maximum. All the remaining clauses of the contract stay valid.
10. If the Boxer's weight is above the weight limit agreed in item 4, he pays a forfeit sum of  
 .....to his opponent independently of the contest taking place or not  
 (see item 11 of the General conditions).
11. In the case of the Boxer for no valid reason not appearing or appearing but being unable to box  
 (fulfil his contract), he shall pay the sum of ..... to the Promoter.

12. Reciprocally, in the case the Promoter not allowing the scheduled contest between the Boxer and his opponent to take place, he shall pay the sum of..... damages to the Boxer.

## **EBU CHAMPIONSHIP GENERAL CONDITIONS**

1. These conditions are subordinated to the Rules and Regulations of the EBU (Articles of Association, Internal Regulations, European Championship Rules, Boxing Rules, Anti-doping Regulations); in case of dispute, the matter will be judged according to these Rules and Regulations, latest edition.
2. No champion nor challenger shall box less than 28 days before he is due to box for an EBU-title.
3. The Referee, the Judges and the Supervisor will be appointed by the EBU, the Medical Officers, the Time-keepers and the Ring inspectors by the EBU-Federation where the contest takes place.
4. From the date of signing the fight agreement to the date of the contest, the Boxer must conform in all ways to present himself at maximum fitness.
5. For all disputes of financial character between the parties, which the EBU is not concerned with, the parties may request a decision by the Court of competent Justice.
6. For all technical or promotional disputes concerning the contest the parties agree to submit the case to the institutions and dispositions of the EBU.
7. Any verbal agreement (not immediately confirmed in writing by the parties) is not valid and cannot be subject of a claim to the EBU.
8. In case of a disqualification during the contest, according to art. 21.3 of the Boxing Rules, the amount of the purse money may be deposited with the Supervisor and withheld pending the decision of the EBU. Travelling and hotel expenses shown on the contract will be paid.
9. Special Matters:
  - a) Boxers, their two companions, Referees, Judges and Supervisor shall be entitled to payment of their travelling expenses (boxers and their two companions from domicile to venue and back; Officials from airport to airport and back) All hotel accommodation shall be paid by the Promoter (board and lodging)  
The Promoter shall take care of the boxers and their two companions from the day of their agreed arrival until the day after the contest (for the Officials from the day of the weigh-in until the day after the contest). He shall propose to them reasonable direct flights (if possible) from and to the nearest airport of their domicile resp. of the venue of the contest. The parties may agree to travel by train or by car. The accommodation (bed and breakfast) for the boxers and their two companions as well as for the Officials shall be at least of three stars standard in individual rooms. The expenses and fees for all Officials must be paid from the Promoter to the Supervisor at the Rules Meeting.
  - b) If the venue of the contest is not available for reasons of force majeure (strikes, epidemics, order of an official body) or by a decision taken concerning the contest preventing it from taking place, and the parties are advised sufficiently early, they cannot claim any indemnity;
  - c) In case of the travelling or hotel expenses being engaged to by the Manager or the Boxer, an indemnity can be asked for, but it shall not be higher than the travelling and hotel expenses shown on the contract;
  - d) The real expenses to be paid for (travel, board and lodging) shall not be higher than the sum stated in the contract, and they shall be paid only on verification by the interested parties. Only following a change in the venue of the contest, the travel expenses may be higher than stated in the contract.
  - e) In case of the contest scheduled to take place open-air and weather conditions are against it, the Promoter must indemnify the Boxer. He may choose another venue without modification of the contract.
10. In the case of a Boxer being declared medically unfit to carry out the contest, he shall immediately inform the Promoter. The Boxer agrees not to take part in any other contest before honouring the present contract, except by permission of the EBU and the agreement of the Promoter.
11. In the case of one of the Boxers exceeding the weight limit, and being unable to make the weight according to the EBU-rules, the contest may take place if both parties agree, according to art. 4.4 of the EBU Boxing Rules.
12. In the case of a Boxer, even with a valid and recognized reason, does not carry out the contest, he

cannot claim the full agreed purse.

13. The Manager and the Boxer agree with the contest to be televised or filmed without asking any additional rights.

14. The manager and the boxer are both aware of the mandatory anti-doping testing after the contest to be carried out by the local affiliated Federation.

By confirming this agreement the local Federation herewith declares to have made all necessary arrangements as allowed within the local laws and regulations to ensure the doping testing to take place for the above indicated contest according to the art. 22.1.1 of the EBU Boxing Rules.

The manager and the boxer decide herewith to continue holding the championship contest, and in the eventuality that the doping testing would not take place, despite all proper preparations, to renounce on any future proposal nor claim regarding the non-existence of the test. They accept to follow and to acknowledge the Anti-doping regulation of the EBU and its decision.
